Name of Grant: **ADULT CAREER GRANT SCHOLARSHIP**

Amount of Grant: **\$500**

Number of Grants being awarded: **Two (2)**

1. ELIGIBILITY

Applicants for the Adult Career Grant must meet the following requirements:

- Applicants must be members in good standing of CSEA Chapter 616
- Applicants must be enrolled in an accredited school of higher education for the fall term, or plan to enroll for the semester/quarter and show proof of enrollment before receiving the grant monies. If enrolled, applicant must provide an official (**sealed**) transcript from the accredited school.
- Enrollment may be either on a full-time or part-time basis.
- "Accredited school of higher education" includes community colleges offering trade or vocational courses, other accredited trade or vocational schools, as well as four-year institutions.
- Applicants must be working towards a definitive degree or a specific career goal.
- Applicant must have a grade point average (**GPA**) of at least 3.00.
- No** prior college assistance grants from our chapter.

2. ADMINISTRATION

Selection of grant recipients will be made by the Scholarship Committee and will be announced at the end of May. Grants will be awarded at the June chapter meeting.

Deadline for returning application and required information is **May 1, 2018**. **Send application via district mail to CSEA: Chris Felde or scan application and email to cseachapter616@gmail.com**

Applicants **MUST** read and complete the application form. All areas on the form must be completed accurately. Failure to do so will be considered grounds for disqualification.

Grant will be awarded on the basis of need, career goals and objective, leadership, character, service, and any CSEA activities.

Grant payment will be made to the recipient upon submission. Proof of enrollment will be required.
